## Financial Aid

In order for a student to receive financial aid, a parent must first complete a financial aid packet and submit it to the Finance Committee. The Finance Committee will distribute aid based on the following criteria:

- Completed financial aid packet
- Letters of reference
- School involvement of the parents
- Commitment of the student
- Community involvement
- Church involvement
- Monies available for financial aid
- Students grade average

After receiving the packet, the Finance Committee will review all of the information and then send a determination letter to inform the applicant of any aid that might be received. This letter will state the terms of the award and a signed copy must be returned. A student's account must be kept current to be eligible to receive financial aid. A student must also keep a "C" average and not be failing any classes at the end of each grading period. A delinquent account or a drop below the acceptable grade level will be reviewed by the Finance Committee and may result in the forfeiture any financial aid that has been awarded.

Financial aid availability varies from year to year dependent upon the amount of monies contributed by donors and the number of applicants for aid. Any financial aid awarded to a student is in a form of a onetime payment from the financial aid account to that student's account allocated in equal amounts over 10 months. If for any reason a student leaves school before the end of the year or the student's account becomes delinquent in their share of the tuition, the remaining amount of financial aid monies in that student's account is forfeited and transferred back into the financial aid account and maybe reallocated by the finance committee as they see fit.
